Ammeter (“Impacts of License Choice and Organizational Sponsorship on User Interest and Development Activity in Open Source Software Projects”) is an assistant professor of management information systems in the School of Business Administration at the University of Mississippi. He received his Ph.D. in organization science from the McCombs School of Business, University of Texas at Austin. His research is focused on the formation and maintenance of organizations made up of knowledge-based workers including the use of software engineering principles in project teams, outsourcing and offshoring IT, and leadership, accountability, and the use of political skill in technical teams. Rajiv D.
