Izak Benbasat (“The Effects of Trust-Assuring Arguments on Consumer Trust in Internet Stores: Application of Toulmin’s Model of Argumentation”) is Fellow of the Royal Society of Canada and is CANADA Research Chair in Information Technology Management at the Sauder School of Business, University of British Columbia, Canada. He currently serves on the editorial boards of the *Journal of the Association for Information Systems* and *Journal of Management Information Systems*, and is a former Editor-in-Chief of *Information Systems Research*. His current research interests include evaluating user interfaces and Web-based recommendation agents to facilitate business-to-consumer electronic commerce.

Andrew Burton-Jones (“Reconceptualizing System Usage: An Approach and Empirical Test”) is an assistant professor in the Sauder School of Business at the University of British Columbia. He holds a B. Comm. and M.I.S. from the University of Queensland and a Ph.D. from Georgia State University. He conducts research on system usage and systems analysis.
