He is a past departmental editor for Information Systems at *Management Science*, immediate past editor-in-chief of *Information Systems Research*, and is a senior editor for *MIS Quarterly*.

**Wolfgang Ketter** (“Research Commentary: Designing Smart Markets”) is an assistant professor of the Department of Decision and Information Sciences at the Rotterdam School of Management, Erasmus University. He received his Ph.D. in computer science from the University of Minnesota in 2007. He founded and runs the Learning Agents Research Group at Erasmus (LARGE), and he is Chair of the Association for Trading Agent Research. He serves on the editorial board of *Electronic Commerce Research and Applications*.

**John Leslie King** (“The Early Years of *ISR*: Recollections of the Editors”) is Vice Provost for Strategy and W. W. Bishop Professor and former dean in the School of Information at the University of Michigan. Along the way he has been Marvin Bower Fellow at the Harvard Business School, distinguished visiting professor at the National University of Singapore and at Nanyang Technological University in Singapore, and Fulbright Distinguished Chair in American Studies at the University of Frankfurt. From 1992 to 1998 he was editor-in-chief of the INFORMS journal *Information Systems Research* and has served as associate editor of many other journals. He has been a member of the Board of the Computing Research Association (CRA) and currently serves on the Council of the Computing Community Consortium, run by the CRA for the National Science Foundation. **Wanda J. Orlikowski** (“Research Commentary: Virtual Worlds: A Performative Perspective on Globally Distributed, Immersive Work”) is the Alfred P. Sloan Professor of Information Technologies and Organization Studies in the Sloan School of Management at the Massachusetts Institute of Technology. Her research examines technologies in the workplace, specifically focusing on the dynamic relationships among information technologies, organizing structures, cultural norms, control mechanisms, communication, and work practices. She received her Ph.D. from the Stern School of Business at New York University.

**Eric Overby** (“Research Commentary: The Design, Use, and Consequences of Virtual Processes”) is an assistant professor of information technology management in the College of Management at the Georgia Institute of Technology. He holds a Ph.D. from Emory University. His research

focuses on the migration of processes to virtual environments enabled by information technology, particularly processes for buying and selling durable goods. His research has appeared in multiple journals and has received awards from the Academy of Management and INFORMS.
