His research interests include individual and interactive decision making. He has published 5 books and 200 journal articles and book chapters, theoretical and experimental, in psychology, sociology, political science, and economics.

Roland T. Rust ("Optimizing the Marketing Interventions Mix in Intermediate-Term CRM") holds the David Bruce Smith Chair in Marketing at the Robert H. Professor Rust is an Area Editor at *Marketing Science*, is founding editor of the *Journal of Service Research*, and serves on the editorial review boards of the *Journal of Marketing Research* and the *Journal of Marketing*.

Venkatesh Shankar ("Practice Prize Article: CHAN4CAST: A Multichannel, Multiregion Sales Forecasting Model and Decision Support System for Consumer Packaged Goods") is a Professor of Marketing and Coleman Chair in Marketing at the Mays Business School, Texas A&M University. His areas of research are Competitive Strategy, e-Business, Innovation and New Product Management, Pricing, Channels, and International Marketing. He specializes in advertising, innovation, new products, market entry, sales promotion, and pricing. He has served as Co-Editor of the *American Economic Review* and is on the editorial boards of several journals. Professor Varian has published numerous papers in economic theory, industrial organization, financial economics, econometrics, and information economics. He is the author of two major economics textbooks that have been translated into 22 languages. His current research has been concerned with the economics of information technology and the information economy. He is the co-author of

a bestselling book on business strategy, *Information Rules: A Strategic Guide to the Network Economy*, and writes a monthly column for the *The New York Times*.

Peter C. Verhoef ("Optimizing the Marketing Interventions Mix in Intermediate-Term CRM") is an Assistant Professor of Marketing in the School of Economics at the Erasmus University in Rotterdam, The Netherlands.
