Eugene W. Anderson (“Invited Commentary: Linking Service and Finance”) is Associate Dean for Degree Programs and D. Maynard Phelps Professor of Marketing at the Stephen M. Ross School of Business at the University of Michigan. His research focuses on customer satisfaction as a business performance metric. He currently serves as area editor at *Marketing Science* and on the editorial boards of the *Journal of Consumer Research* and the *Journal of Marketing*. His recent publications appear in those same three journals. Now in his fifth and final year in the Dean’s office, he looks forward to finding out whether or not there really is life after administration.

Ruth N. Bolton (“Invited Commentary: The Implications of “Big M” Marketing for Modeling Service and Relationships”) is Professor and W. P. Carey Chair in Marketing at the W.P. Carey School of Business, Arizona State University in Tempe, Arizona. Dr. Bolton currently studies how organizations can grow the value of their customer base over time, focusing on high-technology services sold to business-to-business customers. She previously held academic positions at Vanderbilt University, the University of Oklahoma, Harvard University, the University of Maryland, and the University of Alberta. She also spent eight years with Verizon, working on projects in the telecommunications and information services industries. Dr. Bolton’s earlier published articles investigate how organizations’ service and pricing strategies influence customer satisfaction, loyalty, and revenues. Dr. Bolton currently serves on the Board of Trustees for the Marketing Science Institute, the American Marketing Association, and the Sheth Foundation. She has published articles in the *Journal of Consumer Research*, the *Journal of Marketing*, the *Journal of Marketing Research*, the *Journal of Service Research*, *Management Science*, *Marketing Science*, and other leading journals. She currently serves on the editorial review boards of the *Journal of Marketing*, *Marketing Science*, and the *Journal of Service Research*, as well as serving as area editor of the *Journal of Marketing Research*. She previously served as editor of the *Journal of Marketing* (2002–2005). She received her B.Comm., with honors, from Queen’s University (Canada) and her M.Sc. and Ph.D. from Carnegie Mellon University.

Pradeep K. Chintagunta (“Structural Modeling in Marketing: Review and Assessment”) is the Robert Law Professor of Marketing at the Graduate School of Business, University of Chicago. He is interested in studying strategic interactions among firms in

vertical and horizontal relationships. His research also includes measuring the effectiveness of marketing activities in pharmaceutical markets, investigating aspects of technology product markets, and the analysis of household purchase behavior.

Tuck Siong Chung (“Marketing Models of Service and Relationships”) is a doctoral student at the Robert H. Smith School of Business, University of Maryland, College Park. He is also a Senior Tutor at the Nanyang Technological University, Singapore. Her research interests include advertising, branding and brand management, pricing, consumer choice behavior, and customer relationship management. She has published in several journals, including the *International Journal of Marketing Research*, the *Journal of Consumer Psychology*, the *Journal of Consumer Research*, the *Journal of Business and Economic Statistics*, the *Journal of Econometrics*, the *Journal of Marketing Research*, *Marketing Letters*, *Marketing Science*, and *Quantitative Marketing and Economics*. She has also served as the Marketing Group Chair and the Associate Dean for Academic Affairs at the Haas School.

Eitan Gerstner ("Invited Commentary: Why Does Poor Service Prevail") is Professor of Marketing at the University of California, Davis. His articles on pricing, service marketing, and channels of distribution appeared in marketing and economics journals, including *Marketing Science*, the *Journal of Marketing Research*, the *Journal of Service Research*, the *Journal of Business*, the *American Economic Review*, and *Quarterly Journal of Economics*. His most recent research focused on pricing under uncertain demand, on customer acquisition and referrals, and on service and satisfaction guarantees.

Abbie Griffin ("Invited Commentary: Research on Innovation—A Review and Agenda for *Marketing Science*") is a Professor of Business Administration at the University of Illinois, Urbana-Champaign, College of Business, where she teaches business-to-business marketing and first-year core M.B.A. marketing. Liang Guo ("Invited Commentary: Removing the Boundary Between Structural and Reduced-Form Models") is an Assistant Professor of Marketing, Hong Kong University of Science and Technology, China. He holds a Ph.D. in Business Administration (Marketing) from the University of California at Berkeley and a B.A. in Economics from Peking University, China. His recent research interests focus on preference uncertainty, stockpiling, channel bargaining, social information transmission, and empirical analysis of choice behavior and market structure.

Sunil Gupta ("Customer Metrics and Their Impact on Financial Performance") is Professor of Business at the Harvard Business School. Before joining Harvard, he taught at Columbia and UCLA. Sunil's research interests include choice models, pricing, and customer management. His articles in these areas have won several awards, including the O'Dell (1993, 2002) and the Paul Green (1998, 2005) awards for the *Journal of Marketing Research* and the best paper awards for the *International Journal of Research in Marketing* (1999) and the Marketing Science Institute (1999, 2000, and 2003). In September 1999, Sunil was selected as the best core course teacher at Columbia Business School. He is an area editor for the *Journal of Marketing Research* and serves on the editorial boards of the *International Journal of Research in Marketing*, the *Journal of Marketing*, *Marketing Letters*, *Marketing Science*, and *Quantitative Marketing and Economics*. He is a member of the analytical advisory board of Information Resources, Inc. Sunil received his B.Tech in Mechanical Engineering from the Indian Institute of Technology, his M.B.A. from the Indian Institute of Management, and his Ph.D. from Columbia University.

Wesley R. Hartmann ("Invited Commentary: Comment on Structural Modeling in Marketing: Review and Assessment") is an Assistant Professor of Marketing at the Stanford Graduate School of Business. He holds a Ph.D. in Economics from the University of California, Los Angeles. He is interested in applying and developing econometric techniques to analyze questions relevant to marketing and economics. His current research focuses on intertemporal effects of consumption, state-dependent demand, switching costs, and price discrimination in dynamic choice contexts.

John R. Hauser ("Research on Innovation: A Review and Agenda for *Marketing Science*") is the Kirin Professor of Marketing, leader of the Virtual Customer Initiative, and Area Head for Management Science at the M.I.T. Sloan School of Management, where he teaches new product development, marketing management, competitive marketing strategy, and research methodology. He is the co-author of two textbooks, *Design and Marketing of New Products* and *Essentials of New Product Management*. He has received both the Converse Award for scientific contributions and the Parlin award for contributions to marketing

research. For six long years he was editor of *Marketing Science*. Outside interests include sailing, swimming, NASCAR, opera, and country music.

Dawn Iacobucci ("Invited Commentary: Three Thoughts on Services") is the John J. Pomerantz Professor in Marketing at the Wharton School, University of Pennsylvania. She was previously Professor of Marketing at Kellogg (1987–2004) and Arizona (2001–2002). She received her M.S. in Statistics and M.A. and Ph.D. in Quantitative Psychology from the University of Illinois at Urbana–Champaign. Her three research streams focus on dyadic interactions and social networks, customer satisfaction and service quality, and methodological research questions. She is a former editor of the *Journal of Consumer Research* and the *Journal of Consumer Psychology*, and she is co-author on Gilbert Churchill's lead text on *Marketing Research*.

Ganesh Iyer ("Invited Commentary: Internet-Based Service Institutions") is an Associate Professor at the Haas School of Business, University of California at Berkeley. He received his Ph.D. in management from the University of Toronto. His research interests include coordination in distribution channels, competitive strategy, Internet strategy, customer information markets, and the effects of bounded rationality on competitive markets. He is an associate editor at *Quantitative Marketing and Economics* and is on the editorial boards of *Marketing Science*, the *Journal of Marketing*, and *Review of Marketing Science*.

Kevin Lane Keller ("Brands and Branding: Research Findings and Future Priorities") is the E. B. Osborn Professor of Marketing at the Tuck School of Business at Dartmouth College. Keller's academic resume includes degrees from Cornell, Duke, and Carnegie Mellon universities; award-winning research; and faculty positions at Berkeley, Stanford, and UNC. His textbook, *Strategic Brand Management*, has been adopted at top business schools and leading firms around the world. Robert E. Krider ("Invited Commentary: Research Opportunities at the Movies") is an Associate Professor of Marketing in the Faculty of Business Administration at Simon Fraser University, Burnaby, British Columbia, Canada. Current research interests include retail format competition, risky consumption (surprisingly, hang gliding is actually sane), perceptual biases, and competition in entertainment industries. His current favorite movie is "Motorcycle Diaries." His work has appeared in *Marketing Science*, the *Journal of Marketing Research*, the *Journal of Retailing*, and *Marketing Letters*.

Mark A.A.M. Leenders ("The Motion Picture Industry: Critical Issues in Practice, Current Research, and New Research Directions") is an Assistant Professor at the Amsterdam School of Communications Research (ASCoR), University of Amsterdam. His research interests are new product development, innovation and marketing, blockbusters, and communication in particular in media and cultural industries. His work has been published in journals such as *Technology Analysis and Strategic Management*, the *Journal of Product Innovation Management*, *Industrial Marketing Management*, the *Journal of Cultural Economics*, and the *Journal of Media Management*. He obtained his Ph.D. in Marketing and Innovation Management from the Rotterdam School of Management. Currently, he is working on a large study on live performances in the music industry.

Donald R. Lehmann ("Brands and Branding: Research Findings and Future Priorities") is the George E. Warren Professor of Business at Columbia Business School at Columbia University. His research focuses on individual and group choice and decision making, research methodology, the adoption of innovation, and new product development. He is particularly interested in knowledge accumulation, empirical generalizations, and information use. He has published more than 80 articles and books, serves on the editorial boards of several academic journals, and is the founding editor of *Marketing Letters*. He is a past president of the Association for Consumer Research and a trustee and former executive director of the Marketing Science Institute.

Barak Libai ("Invited Commentary: Why Does Poor Service Prevail?") is a Senior Lecturer of marketing in the Leon Recanati Graduate School of Business Administration, Faculty of Management, Tel Aviv University. He has a Ph.D. in marketing from the University of North Carolina at Chapel Hill. His research interests include customer relationship management and, specifically, customer valuation, referral and word-of-mouth analysis, and marketing applications of complex system methods. His work has appeared in journals such as *Marketing Science*, the *Journal of Marketing*, the *Journal of Service Research*, and others.

Michael J. Mazzeo ("Invited Commentary: Marketing Structural Models—'Keep it Real'") graduated with an A.B. degree in Economics and Urban Studies from Stanford University in 1991 and earned a Ph.D. in Economics from Stanford in 1998. Since 1998, Mazzeo has been on the faculty of the Kellogg School of Management at Northwestern University. He is currently an Associate Professor in Kellogg's Department of Management and Strategy and teaches a core class in business strategy to M.B.A. students. Mazzeo's research explores product differentiation and its effects on firm behavior, market structure, and competition among businesses. This research is

empirical, and Mazzeo has developed new econometric modeling techniques to examine the interaction among firm entry, product quality choice, and price competition. He has applied these new techniques in studies of airlines, banking, franchising, health care, retail, and telecommunications. In many of these industries, Mazzeo has found strong evidence that links increased levels of product differentiation with reduced competition among firms. More significantly, the incentive to avoid competition dictates which firms enter particular markets and the types of products they choose to offer.

Charles C. Moul ("Invited Commentary: The Day After Tomorrow: Longer Run Issues in Theatrical Exhibition") is an Assistant Professor of Economics at Washington University in St. Louis. He received his B.A. in economics from Miami University and his Ph.D. in Economics from Northwestern University. His research focuses on the study of market power, advertising, and information within the motion picture industry, and he is the editor of and a contributing author to *A Concise Handbook of Movie Industry Economics* (2005). Despite his ongoing research on such an entertaining topic, his largest impact on the popular culture remains a colorful but losing *Jeopardy!* appearance in 1998.

V. Padmanabhan ("Invited Commentary: Internet-Based Service Institutions") is the INSEAD Chaired Professor of Marketing, INSEAD—Singapore. This paper is part of a research stream that highlights the implications of various contractual mechanisms on the strategic interactions among institutions in a distribution channel and the consequences for institutional as well as overall channel performance. One of his current research projects (largely a consequence of moving to Singapore) is understanding the impact of development in Asia on the evolution of channel institutions, trade practices, and channel management.

A. Parasuraman ("Parsu") ("Invited Commentary: Modeling Opportunities in Service Recovery and Customer-Managed Interactions") is a Professor and Holder of the James W. McLamore Chair in Marketing at the University of Miami. He has published over one hundred scholarly articles and research monographs. He has received many awards for his teaching, research, and professional contributions, including the AMA SERVSIQ's "Career Contributions to the Services Discipline Award" (1998) and the Academy of Marketing Science's "Outstanding Marketing Educator Award" (2001). In 2004 Parsu was named a "Distinguished Fellow" of the Academy of Marketing Science. He served as editor of the *Journal of the Academy of Marketing Science* (1997–2000). He serves on ten editorial review boards and is the current editor of the *Journal of Service Research*. He is the recipient of the "JAMS Outstanding Reviewer Award for 2000–2003" and the "2003 Journal of Retailing Outstanding Reviewer Award." He is the lead author of *Marketing*

Research, a college textbook published in 2004, and is a co-author of three other business books written for practitioners: *Delivering Quality Service: Balancing Customer Perceptions and Expectations*, *Marketing Services: Competing Through Quality*, and *Techno-Ready Marketing: How and Why Your Customers Adopt Technology*. Parsu has conducted dozens of executive seminars on service quality, customer satisfaction, and the role of technology in service delivery in many countries.

Girish Punj ("Invited Commentary: Structural Modeling in Marketing: Some Future Possibilities") is an Associate Professor of Marketing at the School of Business, University of Connecticut, Storrs. He received his M.S. and Ph.D. in Marketing from Carnegie Mellon University. His research has been published in *Marketing Science*, the *Journal of Marketing Research*, and the *Journal of Consumer Research*. His research interests include consumer information search in traditional and electronic environments, structural equation modeling, consideration set formation, and advertising effects on ad and brand attitudes. His research has been published in the *Journal of Marketing Research*, the *Journal of Consumer Research*, *Marketing Science*, and the *Journal of Business Research*. Currently, he serves on the editorial board of the *Journal of Business Research* and is an ad hoc reviewer for several other marketing journals.

Peter E. Rossi ("Structural Modeling in Marketing: Review and Assessment") is Joseph T. and Bernice S. Lewis Professor of Marketing and Statistics at the Graduate School of Business, University of Chicago. He received his Ph.D. from the University of Chicago and his B.A. from Oberlin College. He has published a number of articles in refereed journals in marketing, economics, statistics, and econometrics, including *Quantitative Marketing and Economics*, *Marketing Science*, the *Journal of Marketing Research*, *American Economic Review*, the *Journal of the American Statistical Association*, *Econometrica*, the *Journal of Political Economy*, the *Journal of Econometrics*, *Biometrika*, *Journal of Business and Economic Statistics*, and the *Journal of Economic Theory*. His areas of research interest include pricing and promotion, target marketing, direct marketing, micromarketing, limited dependent variable models, and Bayesian statistical methods. A fellow of the American Statistical Association and the *Journal of Econometrics*, he is founding editor of *Quantitative Marketing and Economics* and a past associate editor for the *Journal of the American Statistical Association*, the *Journal of Econometrics*, and the *Journal of Business and Economic Statistics*. He is Director, Kilts Center for Marketing, GSB, University of Chicago.

Roland T. Rust ("Marketing Models of Service and Relationships") holds the David Bruce Smith Chair in Marketing at the Robert H. Smith School of Business at the University of Maryland, where he is Chair of the Marketing Department and Executive Director of the Center for Excellence in Service. His lifetime achievement honors include the AMA's Gilbert

A. Churchill Award for Lifetime Achievement in Marketing Research, the Outstanding Contributions to Research in Advertising Award from the American Academy of Advertising, the AMA's Career Contributions to the Services Discipline Award, Fellow of the American Statistical Association, the Distinguished Marketing Scholar Award from SMA, and the Henry Latané Distinguished Doctoral Alumnus Award from the University of North Carolina at Chapel Hill. He has won best article awards for articles in *Marketing Science*, the *Journal of Marketing Research*, the *Journal of Marketing* (three times), the *Journal of Advertising*, and the *Journal of Retailing*, as well as MSI's Robert D. Buzzell Best Paper Award (twice) and the Berry-AMA Book Prize. He is the founder and Chair of the AMA's annual Frontiers in Services Conference and was Founding Editor of the *Journal of Service Research*. He is currently the Editor of the *Journal of Marketing*.

Kannan Srinivasan ("Invited Commentary: Empirical Analysis of Theory-Based Models in Marketing") is H.J. Heinz II Professor of Management, Marketing and Information Systems at the Tepper School of Business, Carnegie Mellon University, Pittsburgh, Pennsylvania. He is an associate editor of *Management Science* and an area editor for *Marketing Science* and *Quantitative Marketing and Economics*.

Baohong Sun ("Invited Commentary: Technology Innovation and Implications for Customer Relationship Management" and "Invited Commentary: Dynamic Structural Consumer Models and Current Marketing Issues") is an associate professor of Marketing at Carnegie Mellon University. She develops empirical models to study consumer choice behavior. Her research interests are rational consumer choice and dynamic structural model, evaluation of promotion effect and impact on consumer choice, new product forecasting and survey design, and choice models in CRM. Her recent work focuses on developing dynamic structural models to investigate consumer response to cross-selling campaigns, loyalty programs, call allocation in service centers, new service channels, optimal design of pricing structures in subscription industry, and dynamic and proactive customer relationship management. Her research papers have been published in *Marketing Science*, the *Journal of Marketing Science*, the *Journal of Econometrics*, the *Journal of Business in Economics and Statistics*, etc. She serves on the editorial boards of *Marketing Science* and the *Journal of Marketing*.

Sanjeev Swami ("Invited Commentary: Research Perspectives at the Interface of Marketing and Operations: Applications to the Motion Picture Industry") is an associate professor in Industrial and Management Engineering at the Indian Institute of Technology, Kanpur. He holds a Bachelor's of Engineering in Production and Industrial Engineering from the University of Allahabad, a Master of Technology in Industrial and Management Engineering from the

Indian Institute of Technology, Kanpur, and a Ph.D. in Marketing from the University of British Columbia, Canada. He is a doctoral consortium fellow of the American Marketing Association and a recipient of a University Graduate Fellowship from the University of British Columbia. He has also received AICTE (All India Council of Technical Education) Career Award for Young Teachers and DST (Department of Science and Technology, Government of India) Young Scientist Award. Gerard J. Tellis ("Research on Innovation: A Review and Agenda for *Marketing Science*") is the Neely Chair in American Enterprise, Director of the Center for Global Innovation, and Professor of Marketing at the Marshall School of Business, at the University of Southern California, Los Angeles, CA. He has been Visiting Chair of Innovation, Marketing, and Strategy at the Judge Institute of Management, Cambridge University, United Kingdom and a Distinguished Visitor, Erasmus University, Rotterdam. Tellis specializes in global innovation, new product growth, market entry, advertising, sales promotion, and pricing. He has published over 60 papers and books on these topics (see <http://www-rcf.usc.edu/~tellis/publicat.htm>). His articles have won numerous awards, including four of the most prestigious awards in the field of marketing: the Frank M. Bass, William F. Odell, Harold D. Maynard (twice), and AMA-Berry awards. He has been on the editorial review boards of the *Journal of Marketing Research*, the *Journal of Marketing*, and *Marketing Science* for several years.

Michel Wedel ("Structural Modeling in Marketing: Review and Assessment") is the Dwight F. Benton Professor of Marketing at the Ross School of Business at the University of Michigan and honorary Professor of Marketing at the Department of Economics or the University of Groningen, The Netherlands. His main research interests are in the application of statistical and econometric methods to marketing problems. He has published in, among others the *International Journal for Research in Marketing*, the *Journal of Econometrics*, the *Journal of Applied Econometrics*, the *Journal of Classification*, the *Journal of Business and Economic Statistics*, the *Journal of Consumer Research*, the *Journal of Marketing Research*, the *Journal of Marketing*, *Marketing Letters*, *Marketing Science*, *Psychometrika*, and *Quantitative Marketing and Economics*.
