**Harold Bierman, Jr.** ("The Growth Period Decision") is Professor of Accounting and Managerial Economics, Graduate School of Business and Public Administration, Cornell University. He received a B.S. degree in engineering from the U. S. Naval Academy, and an M.B.A. and a Ph.D. in business administration from the University of Michigan. Dr. Bierman is the author of several books, including *Financial Accounting Theory* (Macmillan, 1965) and *The Capital Budgeting Decision* (co-authored by Seymour Smidt, Macmillan, 1966). He is presently engaged in research on financial policy decisions. Dr. Bierman is a member of American Accounting Association, American Finance Association, and American Economics Association.

**W. Edwards Deming** ("A Markovian Analysis of the Life of Newspaper Subscriptions") lives in Washington and is a consultant in statistical studies. He is also Professor of Statistics, Graduate School of Business Administration, New York University. He received a B.S. in engineering from the University of Wyoming, M.S. in mathematics and physics from the University of Colorado, Ph.D. in mathematics and physics from Yale University, and LL.D. (honoris causa) from the University of Wyoming. He has written with and without co-authors more than a hundred articles; his books include *Statistical Adjustment of Data* (John Wiley and Sons, 1943; Dover, 1964), *Some Theory of Sampling* (John Wiley and Sons, 1950; Dover, 1966), and *Sample Design in Business Research* (John Wiley and Sons, 1960). Dr. Deming has worked in many countries of the world. The Deming Prize is awarded each year in Japan to a Japanese statistician for contributions to statistical theory and to a Japanese company for improved uses of statistical theory, in recognition of Dr. Deming's contribution to the improvement of quality of manufactured product. Dr. Deming received the 2d Order Medal of the Sacred Treasure from the Emperor of Japan in 1960. He is a member of the American Statistical Association, Royal Statistical Society, Institute of Mathematical Statistics, American Society for Quality Control, International Statistical Institute, Philosophical Society of Washington, World Association for Public Opinion Research, Market Research Council, Biometric Society, American Society for Human Genetics, Union of Japanese Scientists and Engineers, Japanese Statistical Association, and Deutsche Statistische Gesellschaft.

**C. F. Fiore** ("The Implementation of Process Models") is Chief Industrial Engineer, Anglo Alpha Cement Ltd., Johannesburg, South Africa. He earned the B.S. degree in chemistry and geology from the University of South Africa. Mr. Fiore is the author of "Control in a Cement Plant," *Founding, Welding, Production Engineering Journal*, March 1967. His present research interests include long range corporate planning and managerial development.
