U. Narayan Bhat ("Sixty Years of Queueing Theory") is Associate Professor in the Department of Operations Research, Case Western Reserve University. He received a B.A. in mathematics and a B.T. in education from the University of Madras, India; an M.A. in statistics from Karnatak University Dharwar, India; and a Ph.D. in mathematical statistics from The University of Western Australia. Dr. Bhat has authored a number of papers, including "Transient Behavior of Multi-Server Queues with Recurrent Input and Exponential Service Time," *Journal of Applied Probability*, Vol. 5, 1968. He is currently working on a textbook on Elementary Stochastic Processes and Their Applications. Dr. Bhat's present research interests include queueing theory, traffic flow theory, and stochastic processes in general. He is a member of TIMS, ORSA, and the Institute of Mathematical Statistics.

John C. Chambers ("Lease-Buy Planning Decisions") is Director of Operations Research at Corning Glass Works, Corning, New York. He was previously affiliated with the Ford Motor Company, North American Aviation, and Ernst and Ernst. He received a B.I.E. and an M.Sc. in industrial engineering from Ohio State University, and an M.S. and Ph.D. in operations research from Case Institute of Technology. Dr. Chambers has published a number of articles, including "Strategic New Product Planning Models for Dynamic Situations," *IEEE Transactions*, Sept., 1968. His current research concerns strategic planning for new products and development of improved forecasting methods, both statistical and models (econometric). He is a member of TIMS and ORSA.
