Sant Ram Arora ("The Sequencing Problem") is an Associate Professor at the University of Minnesota, Minneapolis, Minnesota. He received a B.A. in mathematics and physics from Punjab University in India; he received an M.A. in mathematics from Delhi University, also in India; and he received a Ph.D. in industrial engineering from Johns Hopkins University. Previously, he was a member of the Technical Staff of the Bell Telephone Laboratories in Holmdel, New Jersey, and, in addition, served as a consultant with several industries in the area of inventory and production control, information flow and management reporting procedures. Dr. Arora has published several articles in the fields of inventory and production control, information retrieval, hospital management, planning of natural resources, and library systems. In the past, the author has done research in inventory systems, in particular multi-level inventory systems scheduling and computerized control of production and distribution systems; he is currently researching solid waste disposal and planning of water resources. He is a member of the Institute of American Management, ORSA, and the American Society for Industrial Engineers.

Norman R. Baker ("Computational Analysis of Scoring Models for R and D Project Selection") is an Associate Professor at the School of Industrial and Systems Engineering, Georgia Institute of Technology. He received a B.S. in industrial engineering from Northeastern University and an M.S. in industrial engineering and a Ph.D. in industrial engineering and management from Northwestern University. Floyd Feldmann ("An Optimization Model of Tuberculosis Epidemiology"), until his retirement in 1968, was an Assistant Professor in the Department of Public Health of Cornell University Medical College. In 1924, he received a B.A. from Carleton College in Minnesota; in 1929, he received a B.M. and in 1930 an M.D. from the University of Minnesota.
