Sant Ram Arora ("A Note on Optimal Maintenance Policy and Sale Date of a Machine") is Associate Professor at the University of Minnesota. From 1962-1964 he was a member of the technical staff at the Bell Telephone Laboratories. Among his publications are "Randomized Binary Search Technique" in *Communications of the ACM* (February 1969), "Computer Maker Upgrades Inventory Systems in the *Journal of Industrial Engineering* (June 1969) and "The Sequencing Problem" in *Management Science* (December 1969). His present research interest is the design and management of memory hierarchy problems in computer design. In the past he researched the planning of water resources. He is a member of TIMS, ORSA, and ASEE.

Harry K. Edwards ("Modular Allocation Technique (MAT)") is Associate Professor in the Industrial Engineering Department at the General Motors Institute at Flint. He received a B.S. in mathematics from Youngstown State University, an M.S. and Ph.D. in applied mathematics from the University of Missouri at Rolla. Previously Dr. Edwards was a mathematician and statistician at the Allison Division of General Motors.
