Russell L. Ackoff ("Discussion of the ORSA Guidelines") is Professor of Operations Research at the University of Pennsylvania. He received a bachelor's degree in architecture from the University of Pennsylvania in 1941, a Ph.D. in philosophy of science from the University of Pennsylvania in 1947, and an honorary D.S. from the University of Lancaster in 1967, and the Silver Medal of the Operational Research Society (U. K.) in 1971. Professor Ackoff has held various academic positions at the University of Pennsylvania, Wayne State University and Case Institute of Technology. He has published several books, the most recent of which is *A Concept of Corporate Planning* (Wiley, 1970) and numerous articles in books and journals. He is a member of TIMS, ORSA, The Operational Research Society (U. K.), the American Statistical Association, the Operational Research Society of India, Society for General Systems Research, Beta Gamma Sigma and Sigma Xi.

William P. Allman ("An Optimization Approach to Freight Car Allocation under Time-Mileage per Diem Rental Rates") is an Operations Research Analyst with Sears, Roebuck & Company, Chicago. He received a B.S.I.E. in industrial engineering from New York University, an M.S. in industrial engineering and a Ph.D. in industrial engineering and management science from Northwestern University. In the past, Dr. Allman held positions at the Chicago and North Western Railway Company, the National Bureau of Standards, the Institute for Defense Analysis and the IBM Corporation. His papers have appeared in *Human Factors*, *Proceedings of the Symposium on Simulation of Railroad Operations*, *Proceedings of the Fourth International Conference on Operational Research, Cybernetics and Electronics on the Railways*, *Proceedings of the Fourth National Conference—The Computer in Transportation and Physical Distribution*. Harvey M. Wagner ("Discussion of the ORSA Guidelines") is Professor of Administrative Sciences at Yale University. He received a B.S. and an M.S. in statistics from Stanford University and a Ph.D. in economics from Massachusetts Institute of Technology. Prior to joining the faculty at Yale, Professor Wagner held academic posts at Stanford and M.I.T. He is the author of over fifty papers and notes in *Management Science*, *Operations Research*, *Econometrica*, *Harvard Business Review* and other journals as well as several books, the most recent of which is *Principles of Management Science with Applications to Executive Decisions*, Prentice-Hall, 1970. Professor Wagner's research has been concentrated in mathematical programming, production and inventory theory, and management controls. He has been a Fellow of the American Statistical Association, Associate Editor of *JASA*, Vice-Chairman and Chairman of the Western Section (ORSA), Member and Chairman of ORSA Education Committee, ORSA Visiting Lec-

turer and Departmental Editor for *Management Science*.

William A. Wallace ("A Planning Model for Construction Minerals") is Associate Professor of Management and Director, Program in Public Management at Rensselaer Polytechnic Institute. He received a B.Ch.E. in chemical engineering from Illinois Institute of Technology and holds an M.S. in management

and a Ph.D. in operations research and statistics from Rensselaer Polytechnic Institute. Professor Wallace has published in the areas of mineral resources, planning in higher education and law enforcement. His current research interests include financial planning for new communities and higher education as well as continued work in mineral resource planning. He is a member of TIMS, ORSA and Sigma Xi.
