William J. Abernathy ("Subjective Estimates and Scheduling Decisions") is Assistant Professor at the Graduate School of Business, Stanford University. He received a B.S. in electrical engineering from University of Tennessee and an M.B.A. and D.B.A. in business from Harvard University Graduate School of Business. He is the author of several other articles concerning decision making in R & D projects including: "Parallel-Strategies in Development Projects", *Management Science*, Vol. 15, No. 10 (June 1969) and "Some Issues Concerning the Effectiveness of Parallel Strategies in R & D Management and Procurement", *IEEE Transactions on Engineering Management*, EM-18, No. 3 (August 1971).

John F. Brotchie ("A Model for National Development") is Head, System Research Section, Division of Building Research, Commonwealth Scientific and Industrial Research Organization, Australia. He received a B.C.E. in civil engineering from Melbourne University and a D.Eng. in civil engineering from University of California, Berkeley. He is the author of a number of papers on systems techniques in planning and design and on engineering design and analysis. Dr. Brotchie's past research interest has focused on structural research—analysis and design, computer applications in engineering and systems and decision. Presently he is studying the systems approach to planning, design, and policy making, including urban and regional planning; structural engineering and geo mechanics. His past research interest focused on simulation of solid waste collection systems; presently he is investigating public awareness—attitude arousal, change and measurement—with reference to environmental problems. He received an A.B., an M.A. and a Ph.D. in economics from University of California, Los Angeles. Professor Sharpe has held previous academic positions at University of California, Irvine, and University of Washington. He is the author of *BASIC: Computer Programming Using the BASIC Language* (Free Press), *The Economics of Computers* (Columbia Press) and *Portfolio Theory and Capital Markets* (McGraw-Hill). His papers have appeared in *Management Science*, *The Journal of Finance*, *The Journal of Business*, and *The Journal of Financial and Quantitative Analysis*. Professor Sharpe's research in the past focused on theories of capital asset pricing under uncertainty, simplified methods for portfolio analysis and the economics of computers. Presently he is re-evaluating the traditions and folklore of the investment industry in order to find patterns of behavior that are consistent with new knowledge of the operations of capital markets and the pricing of capital assets under uncertainty. Professor Sharpe is a member of TIMS, American Economic Association, Ameri-

can Finance Association and the Association for Computing Machinery.

Robert L.
