His previous papers, published in such journals as *Transportation Science* and *Traffic Engineering* as well as in various conference proceedings, have dealt mainly with the simulation of public transportation operations. He has also been a Visiting Professor in Industrial and Management Engineering at the Israel Institute of Technology and a Visiting Professor in Operations Research at Stanford University. He is the author of a number of papers in the fields of probability theory, statistical inference and operations research as well as two books: *Probability and Statistics for Engineers* (with M. Klein) and *Finite State Markovian Decision Processes*. His past research efforts were in pure probability theory and statistical inference. He is presently doing research in applied probability theory. Professor Derman is a Fellow of the Institute of Mathematical Statistics and a Fellow of the American Statistical Association.

James S. Dyer ("Interactive Goal Programming") is Assistant Professor in the Graduate School of Management and a member of the staff of the Center for the Study of Evaluation in Education, University of California at Los Angeles. He holds a B.A. in physics and a Ph.D. in business administration from the University of Texas at Austin. His papers have appeared in *Transportation Science*, *Operational Research Quarterly* and *Socio-Economic Planning Sciences*. Professor Dyer's current research focuses on the analysis of complex systems involving multiple decision-relevant criteria with

applications in the areas of education and health care. He is a member of TIMS, ORSA and the Mathematical Programming Society.

Salah E. Elmaghraby ("On Hyperbolic Programming with a Single Constraint and Upper-Bounded Variables") is University Professor of Operations Research and Industrial Engineering, North Carolina State University. He holds a B.S.E.E. from the Moore School of Electrical Engineering, University of Pennsylvania, an M.S. in mathematics from the University of Illinois and a Ph.D. in computer science from the University of Pennsylvania.
