He received a B.S. in Mechanical Engineering from the University of Utah, a MBA in Operations Research from UCLA and a Ph.D. also from UCLA in Quantitative Methods. He taught as an Assistant Professor at the University of Illinois and California State College, Los Angeles, as well as working as a research engineer and statistical analyst. Professor Berhold's articles have appeared in the *Quarterly Journal of Economics*, and *Decision Sciences*. At the present he is engaged in research focused mainly on various topics that are related to the theory of incentives. His general research interests involve the implementation of various normative theories as a basis for formulating models and concepts in decision making environments. Professor Berhold belongs to the Institute of Management Sciences and the American Institute of Decision Sciences.

He holds a B.Sc. and an M.Sc. in Mechanical Engineering from Technion-Israel Institute of Technology, a Diploma in Business Administration from Hebrew University of Jerusalem and a Ph.D. in Business Administration from Columbia University. Dr. Ladany is the author of "Analysis of the Revenue Generating Properties of a Philatelic Postage Stamps Market" in *Developments in Operations Research* (edited by B. Avi-Itzhak), Gordon & Breach, 1970, "Graphical Determination of Single Sampling Plans for Individual Small Lots" in *Journal of Quality Technology* (July 1971), "Determination Graphique des Plans d'Enchantillonage Simple dans le Cas de Populations Normales d'Écart-Type Connu" in *Revue de Statistique Appliquée* (November 1971) and "The Interaction of Linear Programming and Value Analysis" in *Value Engineering* (February 1970). He is also editor of the Hebrew-English Dictionary of Statistical Terminology. His research interests have included Bayesian decision making approach to acceptance sampling and optimal limit-gauging sampling plans. Dr. Ladany is a member of the Operations Research Society of Israel, the Israeli Standards Institute and the Israel Society for Quality Assurance. In addition to his academic interests, Dr. Ladany holds a World Record (1972) for race walking and participated in the Olympic Games in Mexico City (1968) and Munich (1972).

Steven A. Lippman ("Semi-Markov Decision Processes with Unbounded Reward") is Associate Professor in the Graduate School of Management, University of California, Los Angeles. He received a B.A. in Economics and Statistics from the University of California, Berkeley, an M.S. in Statistics from Stanford University and a Ph.D. in Operations Research from Stanford.
