His research activity has been directed to the development of dynamic models of firm and individual behavior by combining the concepts of Management Science with the tools of micro-economic theory. Professor Kunreuther is a member of TIMS and the American Economic Association.

Gary L. Lillien ("A Modified Linear Learning Model of Buyer Behavior") is Assistant Professor of Management at the Sloan School of Management, Massachusetts Institute of Technology. A member of TIMS, ORSA, Tau Beta Pi, and Alpha Pi Mu, Professor Lillien received both a B.S. and a M.S. in Industrial Engineering/Operations Research and a D.E.S. in Mathematical Methods in Engineering and Operations Research from Columbia University. Professor Lillien was formerly Operations Research Associate at the Computer Systems and Management Sciences Department of the Mobil Oil Corporation. Christoph A. Schneeweiss ("Optimal Production Smoothing and Safety Inventory") holds degrees in theoretical chemistry and theoretical physics from the University of Frankfurt and in statistics and operations research from the University of Bonn.
