Currently he is codirector of a Law Enforcement Assistance Administration-sponsored project involving the development of a management information system for the support of strategic planning in an urban police department, and engaged in research and consulting in strategic planning and project management.

Donald Erlenkotter ("Capacity Planning for Large Multilocation Systems: Approximate and Incomplete Dynamic Programming Approaches") is Associate Professor of Planning and Decision Sciences in the Graduate School of Management, University of California, Los Angeles.
