NOTES ABOUT AUTHORS

Cyrus Derman ("A Renewal Decision Problem") is Professor of Operations Research in the Division of Mathematical Methods and Operations Research at Columbia University. He received an A.B. and an A.M. in mathematics from the University of Pennsylvania and a Ph.D. in mathematical statistics from Columbia University. Prior to joining the faculty at Columbia, Professor Derman was an Instructor in Mathematics at Syracuse University. He has also been a Visiting Professor in Industrial and Management Engineering at the Israel Institute of Technology and a Visiting Professor in Operations Research at Stanford University. He is the author of a number of papers in the fields of probability theory, statistical inference and operations research as well as three books. Professor Derman is a Fellow of the Institute of Mathematical Statistics and a Fellow of the American Statistical Association.

George Fishman ("Grouping Observations in Digital Simulation") is a professor of Operations Research and Systems Analysis at the University of North Carolina at Chapel Hill. His principal interest is the development of statistical methodology applicable to the analysis of output from discrete event digital simulation models. He is the author of *Concepts and Methods in Discrete Event Digital Simulation* published by Wiley in 1973 and is a frequent contributor to the operations research literature on this subject. His interests also include time series analysis and has culminated in *Spectral Methods in Econometrics* published by the Harvard University Press in 1969. He also maintains an interest in applied problems. These include a variety of large scale simulation efforts, the application of operations research techniques to health service problems and the quantitative analysis of finances of the performing arts. Prior to his arrival at UNC in 1975, he served as an associate professor of administrative sciences at Yale from 1970-1974 and as a research analyst at the Rand Corporation from 1962-1970.

Professor Kleindorfer's published work has appeared in the *Annals of Math. Stat.*, *Operations Research*, and *Kyklos*. Current research interests include formal models for the design or organizations through incentives and theories of planning under uncertainty. Professor Kleindorfer is a member of AAAS, TIMS, and ORSA.

Howard Kunreuther ("Stochastic Horizons for the Aggregate Planning Problem") is Professor and Chairman of the Decision Sciences Department, Wharton School, University of Pennsylvania. Over the past few years he has been interested in developing model-based approaches to aggregate production and inventory problems facing firms which can be useful to managers and capture their relevant decision-making costs. His most recent research relates to the behavior of decision makers in the face of unlikely events, the results of which are presented in a book just published by Wiley Interscience.
