Dr. Starr was appointed to this position following five years as the founding President of EPRI. From 1967 to 1973, he was Dean of the UCLA School of Engineering and Applied Science, following a 20-year industrial career, during which he was Vice-President of Rockwell International and President of its Atomic International Division.

Dr. Starr received an Electrical Engineering degree in 1932 and a Ph.D. in Physics in 1935 from Rensselaer Polytechnic Institute. He then became a research fellow in physics at Harvard University, working with Novelist P. W. Bridgman in the field of high pressures. From 1938 to 1941, Dr. Starr was a Research Associate at M.I.T. in cryogenics. He has received an Honorary Doctor of Engineering degree from Rensselaer Polytechnic Institute and from the Swiss Federal Institute of Technology.

Dr. Starr became associated with the Manhattan District in its early days at the Radiation Laboratory of the University of Califor-

nia, Berkeley, and later at Oak Ridge. Following WWII, at Rockwell International, he pioneered in the development of nuclear propulsion for rockets and ramjets, in miniaturizing nuclear reactors for space, and in developing atomic power electricity plants. Subsequent activities included energy systems of all types.
