W. W. Cooper ("Some Models for Estimating Technical and Scale Inefficiencies in Data Envelopment Analysis") is the Foster Parker Professor of Management, Finance and Accounting and the Nadya Kozmetsky Scott Centennial Fellow in the Institute for Constructive Capitalism at The University of Texas, Austin, Texas 78712. He is co-editor with Yuji Ijiri of the recently released Kohler's *Dictionary for Accountants*, 6th ed. (Prentice-Hall, 1983), he is currently, with A. Charnes, co-editing a book, *Creative and Innovative Management* (Ballinger, forthcoming) which contains the papers presented at a Conference on that topic in honor of George Kozmetsky. Professor Cooper is a co-recipient (with A. Charnes and R. J. Duffin) of the John von Neumann Theory Prize awarded by TIMS and ORSA in 1982.
