He serves on the editorial review boards of *Strategic Management Journal* and *Academy of Management Journal* and is an Associate Editor in the Planning and Forecasting Department of *Management Science*.

Narayan Bhat ("Reduced System Algorithms for Markov Chains") received his B.A. (Math—1953) from Madras University and M.A. (Statistics—1958) from Karnatak University, India, and Ph.D. (Statistics—1965) from the University of Western Australia.
