Ramakrishna Akella (Ram) ("Ordering and Production Decisions with Supply Quality and Demand Uncertainty") is Associate Professor in the Graduate School of Industrial Administration and the Robotics Institute at Carnegie Mellon University in Pittsburgh, Pennsylvania. At Carnegie Mellon, Professor Akella serves as Director of the Laboratory for Manufacturing and Design in the Graduate School of Industrial Administration and the Director of the Manufacturing Logistics Laboratory within the Center for Integrated Manufacturing Decision Systems (CIMDS) in the Robotics Institute. He completed his B.S. in Electronics at I.I.T. Madras in 1976, and a Ph.D. in Systems at I.I.Sc. Bangalore, in 1982. During 1982, he was a Postdoctoral visitor at Harvard University and a Postdoctoral Associate at MIT, Cambridge, during 1983-85. His research interests are Computer Integrated Manufacturing and range from cell and factory level design and control to enterprise-wide coordination. He has received several awards, including the IBM Faculty Award, and has interacted extensively with industries, including those corporations such as IBM, Digital, and TI, along with various Japanese and European companies.
