Adler ("Behind the Learning Curve: A Sketch of the Learning Process") is currently Assistant Professor in the Department of Industrial Engineering and Engineering Management at Stanford University. He began his education in Australia and moved to France in 1974, where he received his doctorate in Economics and Management while working as a Research Economist for the French government. Before coming to Stanford in 1984, he was a Visiting Scholar at the Brookings Institution, a Visiting Assistant Professor at Columbia University, and a Postdoctoral Research Fellow at the Harvard Business School. His principal research interests are in the management of new technologies in production and engineering operations. He has published widely in academic and managerial journals both in the US and overseas.

Gabriel R. Bitran ("Approximations for Networks of Queues with Overtime") is Professor of Management Science at the Alfred P. Sloan School of Management, Massachusetts Institute of Technology, Cambridge, Massachusetts 02139. He received a B.S. in Industrial Engineering and M.Sc. in Engineering from the University of Sao Paulo in Brazil, and an M.Sc. and Ph.D. in Operations Research from MIT.
