Agha Iqbal Ali ("Strict vs. Weak Ordinal Relations for Multipliers in Data Envelopment Analysis") is a Professor in the School of Management at the University of Massachusetts at Amherst. His primary areas of research are network and integer programming and algorithm design and implementation technology.

M. Douglas Anglin ("Measuring the Long-Term Effects of Public Policy: The Case of Narcotics Use and Property Crime") earned his doctorate in social psychology from UCLA in 1979. Since then, he has been involved in 16 federally funded research projects, most of which deal with the evaluation of community treatment and other interventions for heroin and cocaine users. His work has brought nationwide recognition and invitations to serve as an advisor for a number of organizations, including the Los Angeles County Drug Abuse Program Office, the California Department of Corrections, the Federal Bureau of Prisons, the Office of National Drug Control Policy, and the National Academy of Sciences Institute of Medicine. He is a senior member of IEEE, ACM and ORSA. He is the recipient of the 1972 IPA award and the 1982 AIIE Transactions Development and Applications award, and is past president of ORSA SIG on Telecommunications.

Kurtiss J.
