Shabbir Ahmed (“The Value of Multistage Stochastic Programming in Capacity Planning Under Uncertainty”) is an associate professor in the H. Milton Stewart School of Industrial and Systems Engineering at the Georgia Institute of Technology. His research interests are in stochastic and discrete optimization. His honors include the National Science Foundation CAREER award, two IBM Faculty Awards, and the INFORMS George B. Dantzig Dissertation Award.

Michael O. Ball (“Toward Robust Revenue Management: Competitive Analysis of Online Booking”) is the Orkand Corporation Professor of Management Science in the Robert H. Smith School of Business at the University of Maryland. He also holds a joint appointment in the Institute for Systems Research and is codirector of NEXTOR, the National Center of Excellence for Aviation Operations Research. This work relates to two of his principal research streams: one in air transportation and the other in order promising and fulfillment for assemble-to-order products. The former represents the traditional application domain for revenue management and the latter an emerging domain.

Damian R. Beil (“RFQ Auctions with Supplier Qualification Screening”) is an assistant professor of operations and management science at the University of Michigan’s Stephen M. Ross School of Business. This work is part of a collection of related papers examining procurement and operational measures to mitigate supply risks.

Bahar Biller (“Copula-Based Multivariate Input Models for Stochastic Simulation”) is an assistant professor of operations management and manufacturing at Carnegie Mellon University. Her primary research interest lies in the area of computer simulation experiments for stochastic systems and, more specifically, in the simulation methodology for dependent input processes with applications to financial markets and global supply chains.

Gerald G. Brown (“Interdicting a Nuclear-Weapons Project”) is Distinguished Professor of Operations Research at the Naval Postgraduate School, where he has taught and conducted research since 1973, sustained by support from the Air Force Office of Scientific Research and the Office of Naval Research.

research and teaching interests include network optimization, integer programming, and network interdiction, with application to defending critical infrastructure, counterproliferation, ballistic missile defense, naval logistics, underground mining, and semiconductor manufacturing.

Xin Chen (“A Stochastic Programming Duality Approach to Inventory Centralization Games”) is an assistant professor of industrial and enterprise systems engineering at the University of Illinois at Urbana–Champaign. His research interests include supply chain management, inventory management, and optimization.

Youhua (Frank) Chen (“A Risk-Averse Newsvendor Model Under the CVaR Criterion”) is an associate professor of systems engineering and engineering management at the Chinese University of Hong Kong. His current research interests involve pricing in inventory and manufacturing systems, operational decisions with financial hedging, and revenue management in an e-commerce environment. The technical note grew out of the author’s research on inventory problems with risk considerations.

Robert W. Day (Matrix Bidding in Combinatorial Auctions”) is an assistant professor of operations and information management and Ackerman Scholar in the School of Business at the University of Connecticut. He received his Ph.D. in applied mathematics with a concentration in operations research from the University of Maryland, College Park, in 2004. His dissertation, focused on combinatorial auctions, received the INFORMS George B. Dantzig Dissertation Award in 2005. This paper is an outgrowth of his dissertation. He continues to study combinatorial auctions and other OR applications, including health-care management and grid computing, and has recently consulted on the design and implementation of several spectrum-license combinatorial auctions held by OfCom in the United Kingdom. Other honors include the INFORMS Computing Society Prize in 2008 for his work on the computation and selection of “core-prices” for combinatorial auctions.

Xiaowei Ding (“Time-Changed Birth Processes and Multi-name Credit Derivatives”) is a Ph.D. candidate in the Department of Management Science and Engineering at Stanford University. His research is focused on financial engineering, particularly stochastic filtering and model estimation methods for credit risk. This paper is a chapter in his Ph.D. dissertation written under the supervision of Kay Giesecke.

Thomas Erlebach (“Connectivity Measures for Internet Topologies on the Level of Autonomous Systems”) is a professor of computer science at the Department of Computer Science of the University of Leicester. He joined NPS in 1995 and is currently the NAVSEA Chair Professor of Total Ship Systems Engineering (Combat Systems). He has helped develop numerous advanced sensor systems, advanced weapons systems, and countermeasures to those systems. His research interests at NPS include combat systems, ship design, threat analysis, and terrorist acquisition and use of weapons of mass destruction.

Kai Huang (“The Value of Multistage Stochastic Programming in Capacity Planning Under Uncertainty”) is an assistant professor in the School of Management at Binghamton University, State University of New York. He was an assistant professor in the Department of Technology Management at the Technology University of Eindhoven. His research interests are in stochastic optimization models in supply chain management.

Ramesh Johari (“Efficiency of Scalar-Parameterized Mechanisms”) is an assistant professor at Stanford University, with a full-time appointment in the Department of

Management Science and Engineering (MS&E), and courtesy appointments in the Departments of Computer Science (CS) and Electrical Engineering (EE). Sprowls Award for the best doctoral thesis in computer science at MIT (2004), Honorable Mention for the ACM Doctoral Dissertation Award (2004), the Okawa Foundation Research Grant (2005), the INFORMS Telecommunications Section Doctoral Dissertation Award (2006), and the NSF CAREER Award (2007).

C. Kirkbride (“Index Policies for the Admission Control and Routing of Impatient Customers to Heterogeneous Service Stations”) is an RCUK (Research Councils of the United Kingdom) fellow in the Department of Management Science at Lancaster University. The work on the paper began while he was engaged as a postdoctoral researcher in a major project concerned with indexability issues for restless bandit models. He has a particular interest in the application of such models to the dynamic control of queuing systems.

Donald K. K. Lee (“Optimal Capacity Overbooking for the Regular Treatment of Chronic Conditions”) is an assistant professor of operations management at the Yale School of Management, Yale University. His research focuses on data-driven models for managing health-care delivery systems.

Carlo Mannino (“Optimal Real-Time Traffic Control in Metro Stations”) is an associate professor in the Department of Computer and Systems at Sapienza, University of Rome. His research interests cover various aspects of combinatorial optimization and mathematical programming, also applied to the solution of relevant practical problems arising in telecommunication and railway traffic management.

Alessandro Mascis (“Optimal Real-Time Traffic Control in Metro Stations”) earned a Ph.D. in operations research and is currently sales manager with Bombardier Transportation with the task of marketing and selling railway traffic control solutions in different countries. He coordinated several research projects cofunded by the E.U. on railway traffic optimization.

Sanjay Mehrotra (“Decomposition Based Interior Point Methods for Two-Stage Stochastic Convex Quadratic Programs with Recourse”), a professor at Northwestern University, has pioneered research on the development of interior point methods. This paper builds further upon the body

of knowledge that has been developed in this area for efficiently solving continuous optimization problems. He has also contributed to the methodological understanding in integer programming. He has applied this work to computer graphics, environmental management, bioengineering, and financial engineering.

Linda S. Moonen (“Connectivity Measures for Internet Topologies on the Level of Autonomous Systems”) was a Ph.D. student of the Faculty of Business and Economics at Leuven University during the course of this research, which was part of her doctoral dissertation. She works at the National Centre of Statistics in The Netherlands.

J. Ouenniche (“Index Policies for the Admission Control and Routing of Impatient Customers to Heterogeneous Service Stations”) is a lecturer in management science in the University of Edinburgh’s Management School. The research that gave rise to the paper grew out of a collaboration with coauthors Glazebrook and Kirkbride when all were in Edinburgh. He has a wide range of research interests related to the design and operational management of production and distribution systems.

M. Gokhan Ozevin (“Decomposition Based Interior Point Methods for Two-Stage Stochastic Convex Quadratic Programs with Recourse”) is a senior manager at a Turkish bank. This work is part of his Ph.D. dissertation completed at Northwestern University. He extended the work for more general stochastic semidefinite programs and studied the algorithmic properties and computational efficiency of the proposed method.

Maurice Queyranne (“Toward Robust Revenue Management: Competitive Analysis of Online Booking”) is professor of management science in the Operations and Logistics Division at the Sauder School of Business, University of British Columbia, Vancouver, Canada. The research published in this issue combines his interests in optimization modeling and methodology, in this case the study of online algorithms, with his concern for industrial applications, particularly in transportation, supply chain, and logistics. The collaboration with Michael Ball and the work on this paper were initiated when both were visiting the Institute for Mathematics and Its Applications (IMA) at the University of Minnesota.

S. Raghavan (“Matrix Bidding in Combinatorial Auctions”) is an associate professor of management science at the Robert H. Smith School of Business at the University of Maryland, with a joint appointment at the Institute for Systems Research. His research interests span a wide range of topics including auction design, logistics and supply chain management, telecommunications network design, and health-care and emergency management. This paper is an outgrowth of an interest in devising practical combinatorial auctions methodologies. He serves on the editorial

board of several journals including *INFORMS Journal on Computing*, *Networks*, and *Operations Research*. His honors include the INFORMS George B. Dantzig Dissertation Award (1996), the Glover-Klingman Prize (2005), and the INFORMS Computing Society Prize (2005, 2008).

He is a Fellow of INFORMS and IEEE and a member of the National Academy of Engineering.

Nicolas Vieille (“Protocols with No Acknowledgment”) is professor at HEC Paris. Much of his work deals with stochastic games. Currently, his main research interest is the optimal use of information in dynamic, game-theoretic situations.

Danica Vukadinović (“Connectivity Measures for Internet Topologies on the Level of Autonomous Systems”) was a Ph.D. student at ETH Zurich during the course of this research, which was part of a project entitled “Robustness of the Internet on the Topology and Routing Level.” The goal of this project was to better understand Internet routing problems. had long-term research support from the Office of Naval Research and the Air Force Office of Scientific Research. He has been a visiting faculty member at Stanford University and the University of Auckland and has held the post of Distinguished Visiting Professor at the National Security Agency.

Minghui Xu (“A Risk-Averse Newsvendor Model Under the CVaR Criterion”) is an associate professor of logistics management at the School of Economics and Management, Wuhan University, Wuhan, China. His current research interests include stochastic inventory models with supply uncertainty, inventory-pricing problems with risk considerations, and the impacts of demand variability in the newsvendor setting. Research for this technical note was conducted while the author was visiting the Chinese University of Hong Kong.

Stefanos A. Zenios (“Optimal Capacity Overbooking for the Regular Treatment of Chronic Conditions”) is Charles A. Holloway Professor of Operations, Information, and Technology and Professor of Health Care Management at the Graduate School of Business, Stanford University. His research interests focus on coordination models for complex decentralized technological systems, and models for both centralized and decentralized resource allocation in health-care systems.

Jiawei Zhang (“A Stochastic Programming Duality Approach to Inventory Centralization Games”) is an associate professor of operations management at the Stern School of Business, New York University. His research interests include approximation algorithms, deterministic and stochastic optimization, logistics and supply chain optimization, and production planning and scheduling.

Zhe George Zhang (“A Risk-Averse Newsvendor Model Under the CVaR Criterion”) is a professor in the Department of Decision Sciences at Western Washington University and a professor in the Faculty of Business at Simon Fraser University.
