Balasubramanian (“Optimal Allocation of Surgery Blocks to Operating Rooms Under Uncertainty”) is an assistant professor of industrial engineering at the University of Massachusetts, Amherst (UMass). Prior to joining UMass, he was a post-doctoral research associate at the Department of Health Sciences Research at the Mayo Clinic in Rochester, Minnesota. He was finalist for the Edelman Award in 2001, recognizing his work on semiconductor factory floor scheduling. His research interests include planning and scheduling in semiconductor manufacturing and biopharmaceutical production, economic analysis of import supply chains, and railroad operations and capacity analysis.

He obtained his Ph.D. from the Marshall School of Business at the University of Southern California, Los Angeles.

Alexander G. Nikolaev (“Stochastic Sequential Decision-Making with a Random Number of Jobs”) is an adjunct assistant professor at Northwestern University. He has an M.Sc. from Moscow Institute of Physics and Technology in applied physics and mathematics, an M.Sc. from the Ohio State University, and a Ph.D. from the University of Illinois at Urbana–Champaign in industrial engineering. He is on the faculty of the Department of Civil and Environmental Engineering at the University of Illinois, Urbana–Champaign.
